Updates to the AWERB:

4. **BVS Director report**

- External audits will begin in November or December this year and will look at all aspects of husbandry, management and Home Office-related work. There will be time management analysis to improve efficiency. We do not yet know which facility this will focus on but all staff will be advised in good time.
- We have generated the first draft of a document to help scientists drafting their ethical statements. The draft will soon be distributed to AWERB for review.
- A [REDACTED] communications policy is also in development to harmonise communications across all parts of the department
